In his declaration Kiyoshi NAKAMURA reported two boxes of personal effects stored with Mr. & Mrs. Gordon Horne, Union Bay, B. C. Mr. & Mrs. Gordon L. Horne acknowledged that these boxes were in their care. On November 2, 1942, Mr. Matt Brown, Custodian agent, reported that he had checked and considered that the goods were in safe hands.

Kiyoshi NAKAMURA reported ownership of a \$50.00 Victory Bond, 3 \$5.00 War Savings Certificates and \$1,050.00 on deposit with the Royal Bank of Canada, Courtenay Branch. None of these items were brought under the control of the Custodian.
