We made enquiries through our Steveston representative, Mr. 4, 0, Robinson, on March 12th, 1943 and he advised us on March 16th, 1943, that there were no tools moved at the time the chattels were removed from this address and referred us to List #69, dated Sept. 10/42. We wrote to the above on March 19th. 1943 and advised him that we had found no tools stored at 58 Moncton Street, and asked him to let us know if he had them in his own possession.
