Replying to yours of the 19th instant regarding the above in which you enclosed a letter from Mr. Wright. We would reply to that letter as follows:-

When YOSHIDA registered with the Custodian he registered a claim of \$21.63 against a Mr. Vic Robbins and also claims against three other individuals. These latter three individuals we wrote to and the letters were returned. Therefore, we could not do anything more about it and no funds have been collected, on behalf of the above, from these people.

With regard to his claim against Robbins--which, incidentally, was \$21.63 and not \$25.00 as stated by him to Mr. Wright. Robbins was contacted and at one time agreed to pay \$13.63. We then wrote to YOSHIDA on three different occasions asking him to let us know if this settlement would be satisfactory to him. The first of these letters was dated the 20th of July, 1942 and we did not receive any reply from YOSHIDA until the 16th of October, 1942. We then wrote Robbins several letters--the last one registered, and they were returned by the Post Office with the statement that he had moved and left no address. We accordingly wrote YOSHIDA and told him what happened, a copy of that letter, dated the 28th of January, 1943, is enclosed herewith.

YOSHIDA has no credit with the Custodian and, as far as this office is aware, he has no assets of any kind.
