The above, who made her declaration to the Custodian on April 16/42 and was evacuated April 22/42, declared personal effects in her own possession at 77 Moncton St., Steveston, and a Singer sewing machine in storage at Crone Storage Co., Vancouver.

On June 8, 1943, we received a letter from Crone Storage enclosing a letter they had received from the above asking for shipment of her sewing machine. We wrote on June 12/43 to Crone Storage and gave them permission to make this shipment.

When goods were removed in the name of S. MIYASHITA, one large box of books, one trunk of books and one carton of books were found marked with the name of the above. These were sold at auction for the net sum of \$3.21 and this sum credited to the account of the above. These books are listed on List 463, on File 3324, the file of S. MIYASHITA.

The file reveals the above owned no specified articles.

No property interests other than those mentioned above are found on this file.


