This house was built on property owned by the Canadian Collieries (Dunsmuir) Ltd. This Company paid the sum of \$30.00 to the Gustodian on behalf of KIYONAGA representing salvage value of House #16. A Custodian cheque for the \$30.00 was remitted to XIYONAGA on Oct. 15/43.

KIYONAGA declared chattels as shown on the "hattel Schedule on file. Some of these were shipped as listed on Schedule, the bads were discarded as unsaleable, the balance were sold for the net sum of \$5.47 and this sum credited to the account of KIYONAGA. At is noted that 2 heaters, a chest of drawers and a desk; not declared by KIYONAGA, were among the goods sold and credited to his account. These things were of very little value and it would not seem worth while to transfer them.
