Our attention has been drawn to the fact that you have not yet registered your assets with the Custodian, and as we understand from the British Columbia Security Commission that you anticipate being evacuated shortly we ask that you be good enough to provide us with complete information regarding your affairs by filling out in duplicate the enclosed "JP" registration forms, retaining the third copy for your own use.

You will no doubt be providing us with information in connection with any mortgage which may be held by Messrs. Cameron and Sang on your property.

We cannot stress too strongly the advisability of your providing us, in as much detail as possible, with a description of your land, your interest in the land, encumbrances, if any, on the land, with full particulars of any accounts payable or receivable you may have, giving full names and last known addresses of all individuals involved.

As some other immediate members of your family also may not yet have registered their assets with the Custodian we are enclosing some additional forms for their use and would ask that they be returned to us duly completed as soon as possible.
