

In reply to your enquiry regarding assets of subject Japanese, their account shows a debit balance of \$11.00 and at the time of registration they declared no bank accounts or negotiable assets of any description other than real property.

The property has been advertised for sale by public tender and is to be sold but the proceeds will be sufficient only to cover both mortgages and a creditor, who is willing to accept 50% of his claim.

Mr. Shudo is mentioned as beneficiary on the insurance policies of both his sons.
