Re: Rimuemon TSUTSUMI - Reg. 01714

September 6, 1946.

This Japanese person declared on April 18th, 1942, that he left a Singer Sewing Machine, gramaphone and stove at 754 West 6th Ave., Vancouver. He was evacuated on May 9th, 1942.

The Custodian investigated at the house named on November 7th, 1942 and was informed by the people there that there was nothing belonging to TSUTSUMI. A further enquiry was made by the writer on March 5th, 1946, with the same results. The Department of Labour was advised on this date, as the result of their enquirys that Daiso KISHIMOTO (file 10391) was the former owner of the house and might know something about TSUTSUMI'S effects.

The declarant stated that he had a \$100.00 Victory Bond in his own possession. This was not brought under the control of the Custodian.

No other personal property other than the above is revealed on file.

This summary is certified to be in accordance with the information on file.
