GENERAL SUMMARY File No. 5195 Re: Kinjiro SEKO #08599

February 25, 1947

This man was evacuated on March 12, 1942. On July 21, 1942, having apparently returned to Vancouver to assist his family in moving from Hastings Park, he signed a declaration to the Custodian.

In this declaration, he reported ownership of no chattels. In April, his wife on behalf of her husband, had reported one box of kitchen utensils at the Community Hall, Chemaims. This was shipped by G.P.R. box car to Hastings Park on May 24, 1942. On Movember 27,1942, SMO requested shipment of 5 nailed boxes of kitchenware and a crated sewing madrine from the house of 7. Yamashita, Chemaims. These appear to have been shipped on December 3, 1942.

The sum of \$7.44 was received as refund of one per cent wage deductions on behalf of Kinjiro SEKO. This money was remitted to him on January 19, 1944.

SEMO reported a life policy with the Sun Life Assurance Co. This was not brought under the control of the Custodian.
