We submitted the above claim to UNO for payment and have received his reply admitting that he owes the amount stated. However, he states he is unable to pay, and we quote from his letter as follows:

"I agree that we owe a bill to the Memorial Hospital, but that was agreed upon that I pay after a fishing season. When this war business broke out we Japanese were forced to surrender our fishing craft at a measly sum. What small profit I got from my sale of boat it was barely sufficient to tide my whole family after our arrival here in Manitoba. At present I am working every day and doing my upmost in keeping the family budget going. It is impossible for me to do any thing, as I am doing everything within my power to meet ends meet."

In view of what he says we shall be unable to do more to effect collection at the present time. He has no funds on hand with the Custodian and did not declare any assets, except a few household effects, when registering with the Custodian in April 1942.
