
Chattels found at this house were inventoried by Custodian agent, C.C. Robinson on June 26/42. As noted on the Schedule, the beds, chairs, tables, a wardrobe, cookstove and a few other small items were left in the house, and only some dishes, festival dolls and some misc. goods were removed to storage and sold at auction. The net proceeds from sale of these goods was \$22.88, and this sum credited to her account with this office.

According to inventory taken in October, 1945, 3 pictures and 3 parcels of photographs belonging to Mrs. NAKANO were stored at Buddhist Temple At Steveston. Warehouse has been broken into several times since then. The file reveals the above owned no specified articles.

MR. COBUS: The claim, your honour, of Nakano, Matsue,
which is No. 57 on the Secretary's list, and
which becomes case No. 291, Mr. Secretary, I
take it.

THE COMMISSIONER: 291 from 57.

THE SECRETARY: 291.

MR. COBUS: I am calling, your honour, K. Nakano.

10 KUZUO NAKANO, the Claimant herein, being first
duly sworn, testified through
the official interpreter as
follows:

MR. COBUS: I would ask leave, your honour, to amend
the claim by adding the witness, Kuzuo Nakano
as a joint claimant in this case.

THE COMMISSIONER: That is, jointly with Matsue, is
it?

MR. COBUS: Yes, your honour.

DIRECT EXAMINATION BY MR. COBUS:

20 Q: Witness, I produce to you a claim form which is
signed by M. Nakano. Do you recognize that
signature? A: It is his wife's
signature.

Q: That is your wife's signature?

A: Yes.

Q: And the property for which your wife submitted
the claim is the joint property of yourself and
your wife, is that correct? A: Yes.

30 MR. COBUS: With respect to the claim itself, your
honour, which is for personal property, we have

eliminated the typed portion under 5 (e) and have replaced it by showing household effects and fishing equipment as valued at \$233.50.

THE COMMISSIONER: Household effects and fishing equipment.

MR. COBUS: Yes, your honour.

MR. McINNIS: For how much?

THE COMMISSIONER: What is the amount?

MR. COBUS: \$233.50. We have credited the Custodian
10 with \$20.35, leaving a net claim of \$213.15 which amount is shown under 5 (f) as well.

Q: Witness, I produce to you a statement concerning the personal chattels which is the subject matter of your claim and that of your wife. Did you instruct Mr. Leckie to prepare this statement for you and is that your signature?

A: Yes.

Q: The statements contained therein, are they true to the best of your recollection?

20 A: Yes.

Q: In your statement you have listed certain items. Does that list all of the items for which you are making claim? A: Yes.

Q: In the extreme right-hand column there are certain values shown against each item. Do those values represent what you consider to be a fair market value for each item as valued?

A: Yes.

MR. COBUS: I would ask to file the statement concerning
30 personal chattels, your honour, as the first

exhibit.

(STATEMENT MARKED EXHIBIT NO. 1)

MR. COBUS: Referring to the statement, your honour, the items listed in the statement except the final item are what the witness has described as household effects. The last item is one carton of fishing gear which contained 10 pounds of hanging twine and four pounds of net twine. The claimant has given the details with respect to the date of purchase as to each item, whether it was new or used, when purchased, price paid, approximately, and its condition when evacuated.

10

The statement reads that the storage of all goods was house No. 2 at Phoenix Cannery, Steveston, B.C. The witness in his statement says that his wife declared these goods for him and the Custodian sent her monies for proceeds from such goods as he sold. The goods were actually their mutual property and he is now representing his wife and himself in connection with the current claim. He adds that he has allowed for depreciation on all the goods, used articles and unused articles are claimed at cost price.

20

THE COMMISSIONER: Well, the wife would have made her declaration on the J.P. form, would she?

MR. COBUS: That is correct, your honour.

THE COMMISSIONER: And he made no J.P. form, I presume?

MR. COBUS: I think perhaps if I asked my learned friend to produce the Analysis of Personal Property Claim that will indicate the declaration.

30

THE COMMISSIONER: Yes.

MR. COBUS: I would ask to file the Analysis of Personal Property Claim in this case on behalf of the Crown.

(ANALYSIS MARKED EXHIBIT NO. 2)

MR. COBUS: Would my friend produce the signed inventory of chattels in respect to this claim?

(Handed to Mr. Cobus)

10 Q: Witness, I produce to you a list of chattels under the name of Nakano, Matsue, in brackets, Mrs. Kasue, file 5267, under registered No. 03844. Would you look at that list and tell me if you have seen that list before?

A: This is the list the Custodian had sent to me.

Q: Were the pencil marks and lines on the list when you first saw it? A: No, the marks were not there.

Q: How many copies of this did you receive?

20 A: He received two and he sent one back to the Custodian.

Q: Who signed the one that was returned to the Custodian?

A: He thinks it is his wife.

MR. COBUS: Your honour, I was under the impression that the signed copy of that inventory was in the Custodian file, but it doesn't appear to be there now.

THE COMMISSIONER: What is that, just a copy of it, Mr. Cobus?

30 MR. COBUS: Yes, your honour. The note at the bottom

E. Nakano
In Chief

explains what was to be done with it.

(Handed to the Commissioner)

THE COMMISSIONER: This checks, I presume, with the list, the inventory on the Analysis of Personal Property Claim, doesn't it?

MR. COBUS: Very closely, it does, your honour.

THE COMMISSIONER: It should do.

MR. COBUS: As a matter of fact, it is an exact copy of it.

10 THE COMMISSIONER: Perhaps you will want to check it. You might check to see if that was presumably what it was taken from.

MR. COBUS: I think there is no doubt about it, your honour. I won't bother asking to file this, but refer, rather, to the Analysis of Personal Property Claim in column 2 under the heading "Inventory" with the date 26th June, 1942. That will serve the purpose, I think.

20 Q: Witness, I produce to you a form which is headed "Analysis of Personal Property Claim, which is Exhibit --

THE COMMISSIONER: That is Exhibit No. 2.

MR. COBUS: Q: Exhibit 2, and point out, in a column under the head "Abandoned" certain X's which refer to an item of five chairs, two beds and springs, a wardrobe, and a cookstove, which, judging from the Analysis sheet, were abandoned by the Custodian.

THE INTERPRETER: It was abandoned?

30 MR. COBUS: Just tell him that much, and I will ask

the question.

THE INTERPRETER: Yes.

(Interpreter to witness)

MR. COBUS: Q: Can you suggest any reason, yourself, as to the reason why the Custodian would abandon those particular items?

A: "I don't know," he says, "I can't think of anything."

10 Q: For instance, with reference to the cookstove in your statement marked exhibit 1, you say that you purchased it in 1938 and that it was new and that you bought it for \$45.00 and its condition was good on evacuation and you value it at \$25.00. Was that stove still a stove that you could use quite well at home?

A: Yes.

20 Q: With respect to item No. 2 in your statement, five kitchen chairs, you say they were purchased in 1938 new at a cost of \$7.50 and you stated their condition to be good when you were evacuated, and you valued them at \$5.00. Were those five chairs still useable as chairs?

A: Yes, I could use them. I would like to have them back.

Q: You would like to have them back. With respect to those two items, the cookstove and the chairs, and the other items described as "abandoned," in your opinion would those goods have some sales value?

A: Yes.

30 Q: And the estimated values that you show in your

statement marked Exhibit 1 are your considered
opinion as to the fair market value for such
items?

A: Yes.

MR. COBUS: Your witness.

MR. McINNES: It is submitted, your honour, that the
items now claimed for were not declared in the
J.P. form. It is further submitted that such
of the goods as came into the possession of the
Custodian were sold for their fair market value,
and in respect to any others which did come into
the Custodian's possession and were not sold
or accounted for, that the claim of this claimant
is excessive.

CROSS EXAMINATION BY MR. McINNES:

Q: Witness, your wife made a J.P. form in this case,
is that correct?

THE INTERPRETER: He is rather doubtful. Could he
see that?

MR. McINNES: Q: That is your J.P. form?

A: Yes.

Q: Whose signature is that?

A: It is my wife's.

Q: That claim was made on behalf of yourself and
your wife?

A: Yes.

Q: You have no separate claim other than this one?

A: No.

MR. McINNES: That is all, thank you.

Your honour, it would appear that the file
I have here is somewhat incomplete, inasmuch as

there appears there were a number of goods left in the house. Just what happened to them I don't know. The file gives no indication of them, whether they were abandoned as of no value or whether they were stolen or what happened.

THE COMMISSIONER: You have no explanation of the goods abandoned other than they were abandoned?

MR. McINNES: That is a matter that will be clarified at the defence. I didn't hear your question,
10 your honour.

THE COMMISSIONER: You have no record other than the fact as stated here that they are abandoned; you don't know for what reason or under what circumstances?

MR. McINNES: No, your honour. It says on my chattel schedule that they were left in the house.

THE COMMISSIONER: Yes.

MR. McINNES: I wish to point out, further, in the
20 J.P. form which this witness admits his wife sent in, that there are quite a number of the items that they are now claiming which were omitted. To list a few, there is no claim in the J.P. form for a baby's high chair, for a carton of cushions, for a cookstove, for the Japanese dolls, or for the carton of fish gear. That is all, thank you.

THE COMMISSIONER: Well, would it be as well, under those circumstances, to file that J.P. form so that it is available?

30 MR. McINNES: Yes, I think perhaps it would.

THE COMMISSIONER: I think it would, so that it will be available for the claimant.

10 MR. COBUS: Your honour, with respect to the last submission of my learned friend, I would refer again to Exhibit 2, the Analysis of Personal Property Claim. The first column obviously is a copy of the personal chattels declared in the J.P. form which my learned friend is now filing, but the second column is an inventory taken on the 26th of June, 1942, and if that is examined and compared with the claim as submitted in the amended form, it will be seen that every article that we have claimed for was inventoried by the Custodian. Therefore, it is rather difficult for me to understand how the Crown is able to submit that any of the goods for which claim is being made did not, in some way or other, come into the hands of the Custodian.

20 THE COMMISSIONER: Well, the question is, why were they abandoned? I suppose that is the whole question.

MR. COBUS: Well, that, your honour, is for the Crown to explain.

MR. McINNES: Well, I will file the J.P. form as an exhibit.

THE COMMISSIONER: Yes.

(J.P. FORM MARKED EXHIBIT NO. 3)

MR. COBUS: No more questions, your honour.

THE COMMISSIONER: All right, Mr. Nakano, that is all for the time being.
