I wish to advise you that the Custodian's office will have no objection to your making arrangements with your own real estate agent to look after your property but, of course, the Custodian's office will require to be satisfied that such person is reliable and capable of handling your property satisfactorily. The revenue from this property will be used to pay taxes, insurance and similar charges on the property and any remaining balance will be made available to the owner of the property provided he has no outstanding debte in the protected area. If you desire to have a portion of the revenue of your property over and above expenses used to pay like insurance premiums there should be no difficulty in arranging this. Once property is registered with the Custodian it wests in the Custodian and can only be dealt with with the written approval of the Custodian's office. It is our policy, however, not to object to sales of small household articles where Japanese reculre to seld them in order to get money for living. Similarly, if the owner of the property arranges a deal to dispose of his property which is satisfactory to him
the Custodian's office would, in all probability, give approval
to it if it seemed reasonable. If the owner had no debts it
