This man signed a declaration to the Custodian on April 22, 1942. He was evacuated on April 28, 1942. In his declaration he reports the following assets:

War Savings Certificates to the value of \$65.00 in the owner's possession.

A bank account with the Royal Bank of Canada, East End Branch, Vancouver, in the amount of \$75.00.

Personal clothing in his own possession.

The War Savings Certificate and bank account did not come under the control of the Custodian.

The personal clothing would, undoubtedly, be taken with him on his evacuation.

The file reveals no interest in any property dealt with in any other file, and no assets except those declared are revealed in this.

The file reveals no liabilities.
