This man signed a declaration to the Custodian on April 21, 1942.  
He was evaluated on June 29, 1942.

In his declaration he reported a 1943 DeSoto sedan in custody. This car was sold and the net proceeds of \$172.79 were credited to the account of this man. We remitted six payments of \$25.00 to SHINODA on March 30, 1943, October 1, 1943, October 30, 1943, November 30, 1943, December 31, 1943 and January 28, 1944 and on March 2, 1944 we remitted the balance of \$22.79.

He reported two shotguns and a rifle in custody. Firearms are handled by the R.C.M.P. and do not come under the control of this office.

He reported a \$1,000.00 policy with the Sun Life Assurance Co. This did not come under the control of this office.
