Replying to your request directed to Mr. Watson of the Japanese Property Claims Commission for a statement covering the account of Ichijiro UYEMURA, we now enclose a copy of this statement brought up-to-date. Since the amount at credit was forwarded to you upon your appointment as Administratrix the account has been credited with the sum of \$80.00, being for redemption of Pacific Co-operative Union Shares. We enclose herewith Custodian cheque for this amount, payable to you as Administratrix, together with a copy of the Auction Sheet showing the goods sold by auction.

In addition to those, two beds were appraised by Laurence, Auctioneers at Mission City, for \$6.00 and \$2.00 respectively and sold to the tenants on the premises. One section of harrow was appraised at \$4.00 and one sprayer at \$3.00 and also sold to the tenant.

Some other farm equipment was reported in 1942 to have been sold by your father to Mr. Bontron when he leased the property to him.
