"The \$40.00 with Dr. Hankinson must be sometime ago as we don't recall having such a big bill. However, since we lost everything during evacuation, we cannot pay such a large sum now. Please check carefully and ask Dr. Hankinson for a more detailed bill."

In view of the foregoing we shall require a full statement of this account in duplicate, so that we may forward to HIRANO the information he requires.
