PERSONAL PROPERTY SUMMARY File No. 5514 Jaly 30, 1947 Rei Tadao TATEISHI, Reg. No. 08979 This man was a millhand at Paldi, B. C. He signed a declaration to the Custodian on April 24, 1942, at Hastings Park. He was evacuated on July 13,1942. In his declaration TATEISHI reported the chattels listed in the Chattel Schedule, and stated that these were at the Japanese Hall, Paldi. No inventory was taken of the goods in this hall. Shipments were made from time to time by Mayo Bros. Timber Co. Ltd. This office was not informed of these shipments, and it is not clear what was shipped. The goods sold at Duncan, on March 15, 1945, and at Vancouver Auctions Nos. 62, 63, & 64, were identified as the property of TATRISHI by the men handling the sales. The net proceeds credited to this account from the sale of chattels were \$81.29. TATEISHI reported \$35.00 in War Savings Certificates in his own possession. These were not brought under the control of this office. The file of Hatsu TATEISHI, wife of Tadao TATEISHI, refeals no property. This file reveals no other property of any kind. This summary is certified to be in accordance with information on file. July 30,1947.
