In his declaration to the Custodian, April 17, 1942, this man declared a \$200.00 Victory bond in his own possession. This did not come under the control of this office.

He also declared a Sun Life Assurance Policy for \$1000.00. This did not come under the control of this office. It is noted, however, that on January 7, 1946, we forwarded a cheque from the Sun Life Assurance Company for the sum of \$376.31 in full settlement of all claims under Policy No. 2,075,350 on the life of Takeo MATSUMOTO. Cheque was payable to this man and his wife.

The sum of \$7.66 was credited to this account. This was a refund of one per cent wage deductions for 1941 received from the Provincial Government of British Columbia.

A Briggs-Stratton inboard motor was delivered to the Custodian by Naval Service in April, 1943, and was sold by the Custodian for the total sum of \$19.00. Expenses in connection with this sale (appraisal and advertising) amounted to \$5.06, leaving a balance of \$13.94 which was credited to the account of Takeo MATSUMOTO.

This file reveals no other property of any kind.
