Mr. Sotojiro Takada (File 5559) was credited with \$5.71 and \$7.28 from 15 Wage Refund. Upon investigating and phoning the City Hall, it was found that the refund of \$7.28 came from the Vancouver Tobacco Company and should, therefore, be credited to Sotojiro Takada (File 5559). The City Hall had spelt the name wrong in connection with the amount of \$5.71. Upon learning that it should be spelt TAKATA, we find that this amount should be credited to Sunao Takata, (File 11784) who formerly worked for the B. C. Pulp and Paper Company, where the refund came from.

However, the amount of \$5.71 has already been sent to Sotojiro Takada (File 5559) and as his refund is \$7.28, this leaves him an amount of \$1.57 to his credit with us. Please, therefore, transfer the amount of \$5.71 from File 5559 to File 11784.
