
Re: Tokubei SASAKI - Reg. No. 13737

The only assets declared by the above Japanese was a Canadian Mutual Benefit Association policy and a Bank account at Haney. These however were not brought under control by the Custodian.

The Canadian Indemnity Company filed a claim for the balance of B.C. Electric Company bond, but as this was assumed by the purchaser of SASAKI's property, no action was taken.

This file reveals no other liabilities and no further administration is necessary on the file. It may now be closed.
