Further to my letter to you of March 12th with reference to the two life insurance policies listed above covering on your own and your brother's life, in connection with your policy No. 2,084,860 I notice that the next annual premium of \$26.55 will become due on November 1, 1943, and that premium on Policy No. 2,289,129 on your brother's life will become due on April 25, 1943.
