In his declaration to the Custodian, April 25, 1942, this man declared the following:

Securities: \$40.00 worth of War Savings Certificates at home.  
These did not come under the control of the Custodian.

Life Insurance: Sun Life Assurance Company of Canada -Policy #2234558  
Amount \$1,000.00 - 25 year endowment policy  
Beneficiary: Father (now deceased)  
Premium paid from account of brother, Toyozo, File 7352,  
on Sept. 1, 1943. This policy did not come under control  
of Custodian.

Accounts Receivable: Hiroshi HOYAMI declared none, but the Provincial  
Collector, Vancouver, paid in to the Custodian  
the sum of \$5.26, being refund of 1% Wage Tax  
for first six months of 1942. This sum was  
credited to Hiroshi HOYAMI's account, and remitted  
to him on January 17, 1944.

The file reveals no evidence of ownership of a vessel, motor-vehicle, radio,  
of camera.

There is no evidence of ownership of any other personal property of any kind.
