The claims and memorandum regarding shot gun and rifle, concern Saul KADONAGA, formerly of Queen Charlotte Islands. I think these should be on the file of Sokichi KADONAGA, Reg. 12779, File 4622. Sokichi KADONAGA was from Cumshewa Inlet, Queen Charlotte Islands, and was known as "Saul".
