Authentic information came to me today which I pass on to you.

Mrs. Johnson re-rents the pool room, with two pool tables, equipment, stoves, chairs and benches for \$30.00 per month. Five or six rooms upstairs are rented by her for, I believe, \$8.00 per month each.

She operates the store and restaurant herself.

It would seem that she is deriving quite a revenue while only paying to the Custodian \$15.00 per month plus the water rate.

Recently she complained re a leaky roof and we have authorized its repair to cost \$35.00.

All of the above looks like exploitation to me. I do not know what the original arrangements were between the MUKAI's and Mrs. Johnson but same should be closely scrutinized.
