Letter from Mr. McMaster, of JFVDC, states that this vessel was licensed in the name of G. Sugoro. It is true that Lic. NW.1380 was issued to G. Sugoro, but he received licence in 1922 and the "G.K.1380" was only nine years old in 1942. The name "G.K.1380" would indicate that the numbers are those of a fishing licence, not a gas-boat licence. G. Sugoro is not registered with the Custodian. It seems safe to assume that there is no connection between G. Sugoro and the "G.K. 1380".
