Since the above Evacuee resided at 96 Moncton Street which is the same address as Mrs. Yoshiso Mukai, Widow, Registration No. 04273, File #5867, we presume this to be the "Mrs. Mukai" referred to in her letter.

Mr. Mackedie replied on October 23rd, 1945, "The few effects belonging to Mrs. Makagawa taken from the house of Mrs. Mukai, were of no saleable value and were abandoned."
