January/June, 1941.

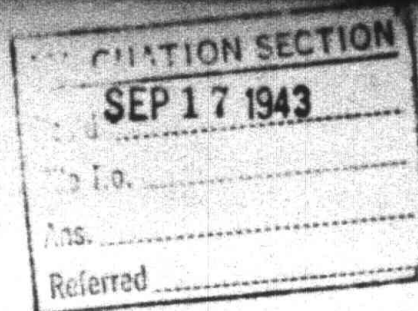
