

Dear Sir:

Your letter addressed to Mr. Buchanan was turned over to the writer to answer.

We attach herewith copy of statement showing a balance owing of \$75.00. This was your balance when you left Sunnyside at the end of 1941.

The writer discussed the matter of the cordwood with Mr. Wallace and he stated that we could not be responsible for any wood claimed to have been stored nor did he make any statement to the effect that the wood would be kept and turned over to you upon your return to the coast. All settlements with Japanese were made before they were evacuated, and we cannot entertain any responsibility for your statements.

We feel sure after you receive copy of this statement you will realize that you owe this money and will remit same direct or through the Custodian.
