#### PERSONAL PROPERTY SUMMARY

Kiyoshi Yamanaka declared on April 20, 1942, that he had no property of any kind whatsoever in the Protected Area.

It was later discovered that there was a Life Insurance policy with the Mutual Life Insurance Company, Policy No. 554346.

On September 21, 1944, a letter was received from the Mutual Life insurance Co. asking for our authority to forward to the Assured the cash settlement of this policy, amounting to \$78.40. The Custodian's letter to the Mutual Life Insurance Co. of September 22, 1944, stated that the Custodian had no objection to the above policy being surrendered for cash, providing the cheque was sent to Kiyoshi YAMANAKA through this office.

There is no further record on file of this policy being surrendered. As this did not come under the control of the Custodian no further action is required.

No property interests other than those mentioned are found on the file.
