This man signed a declaration to the Custodian on April 27, 1942, in which he reported that he owned no property of any kind in the projected area.

The account of this man was credited with the sum of \$4.45 received as refund of 1% wage deduction for 1941. This was remitted to him on January 17, 1944.

R.C.M.P. information shows this man to be the owner of a Pontiac Sedan, 1938. As this man did not declare this vehicle and we have no record of this man owning a car, we assume he disposed of it prior to date of forced surrender.
