Thank you very much for your letter dated July 21st. We have searched our files in an endeavour to identify the claim of your clients, the Cumberland General Hospital. The following information, although not entirely satisfactory, has been revealed and may perhaps be of some assistance to you:-

Our File No. 6315 covers Mrs. Kiyu Fujimoto, a housewife aged 50, who gave her address as Box 393, Cumberland, B.C. This Mrs. Fujimoto declared to us on April 25th that she had no assets whatsoever.

Our File No. 3478 covers Mr. Kaname Fujimoto, a grocery clerk aged 26, unmarried, who at one time was employed by the firm of K. Kanaka of No. 394 Powell Street. This Mr. Fujimoto also declared to us when he registered on April 11th that he had no assets whatsoever save income of \$13.30 per month from the Workmen's Compensation Board which was being applied monthly towards reduction of a debt of \$250.00 owed by him to his former employers.
