Dear Sirs:

Re: Estate of Keijiro MATSUI, #03651, Deceased.

We have to acknowledge your letters relative to the above and note that you have been instructed to probate the will of the late Keijiro Matsui.

The assets of the deceased at present under the control of the Custodian consist of a credit balance in this office of \$264.22 and 82 unredeemable Pacific Co-Operative Union shares covered by share certificate No. 159. One cent interest per share per year accrues on these unredeemable shares. A statement of the account of the deceased from the date of death is enclosed herewith.

The amount at credit as of June 12, 1946 is made up of the undisbursed balance from sale of real property, a truck, personal property, and Pacific Co-Operative Union redeemable shares. Remittances made from time to time have reduced his account to this balance. The item \$170 represents redemption of 17 P.C.U. shares at \$10 per share, and the item \$5.02 represents interest to November, 1946 on these shares together with .82¢ on the unredeemable shares to that date.

Unaware of Keijiro Matsui's death a cheque for \$400 was mailed to him on June 17, 1946, and although this man is now reported to have died on June 12th, this cheque was cashed in July, 1946, having been endorsed "K. Matsui". You might be interested to investigate the identity of the person who endorsed this cheque and received the cash. The signature does not appear to be that of the deceased.

With reference to liabilities, none are indicated on our file with the exception of a possible guarantee of an indebtedness of Machira Taise to S. Amano, but our information regarding this is not sufficient to consider it an actual claim against the estate.

With reference to the last paragraph of your letter of April 24th, our file does not disclose any claim filed by this deceased with respect to expropriation of any property. We did however, receive on October 13, 1946, a letter of complaint signed K. Matsui.
