MEMORANDUM

From a brief review of these files, it is noted that Yasemon TAMURA owned no real estate and resided with his sons at Haney.

He declared chattel: some of which have been shipped to him, the rest being sold by auction for the sum of \$84.89.

The file also reveals that he owned one \$100.00 Victory Bond and 76 shares in the Maple Ridge Co-op, 5 of which have since been redeemed. He also declared an account with the Bank of Montreal, with a balance of \$100.00.

The claims filed against Yasemon amount to \$15.00 and are disputed.

The file of Yuri TAMURA, wife of Yasemon, reveals no property or liabilities of any kind.
