



Pursuant to your instructions of the 28th ult., our representative proceeded to the above address and investigated the position of affairs. Resultant details are shown below in the order given in your instructions re agents' reports.

REAL ESTATE AND PERSONAL PROPERTY

Real Estate:

As Kanamatsu, according to advise received from the Royal Canadian Mounted Police, was evacuated to Red Pass on March 10th, 1942, we have been unable to question him regarding ownership of any real estate. Although conversations with several parties said to be familiar with his operations did not disclose that he possessed any realty, further enquiries are being made in that connection.

Personal property:

We have, as yet, been unable to ascertain the full extent of personal property owned, although certain funds amounting to \$200.00 and said to belong to Kanamatsu, are in the hands of K. Sano, Japanese of 396 Powell St., Vancouver, B.C. The latter party reported he is holding the money in trust for Kanamatsu, pending instructions of the Custodian regarding its disposition. It appears the money represents proceeds from the sale of Kanamatsu's stock and fixtures to a Mr. J. G. Foster, who is now living in the store premises.

BUSINESS

1. Location and nature of business:

Location:

244 East Broadway, Vancouver, B.C.

Nature of business:

Small grocery and confectionery store.

2. Particulars of ownership:

Status of title has not yet been determined, although contact with the landlord and the fact that there are electricity and gas deposits at the subject's credit with the B.C. Electric Railway Company, indicate the business was operated and probably owned by M. Kanamatsu.

3. Statement of Assets and Liabilities:

Assets:

Proceeds of sale of business to J.G. Foster, amounting to \$200.00, held by K. Sano, 396 Powell Street, Vancouver, B.C. In addition we are advised that electricity and Gas deposits are at the credit of the declarant although the amounts have not yet been obtained from the B.C. Electric Railway Co. 

Liabilities:

K. Sano claims \$70.00, arising from an alleged loan to Kanamatsu before the latter's evacuation. The former disclosed the money was advanced to cover living expenses of the subject and his two daughters aged 12 and 15 years. 

We are advised there is no outstanding liability for rent. Further information regarding the financial status is being sought, including clearances in respect of any liabilities owing the Provincial and Dominion Governments.

4. Insurance in force:

No insurance coverage of any kind was disclosed during our investigation.

5. Contracts affecting business:

So far as we have been able to learn, there are no existing contracts affecting the declarant's business.

6. General remarks:

It is reported that M. Kanamatsu is a widower and that his two daughters are now living with their aunt, Mrs. Tsuji at 325 W. 4th Ave., Vancouver, B.C. We are further informed that resources of the family are very limited.

As the new tenant wishes to arrange for gas and light service in his own name, we have requested the B.C. Electric Railway Co. to refund Kanamatsu's deposit to us which will be held if and when received, pending receipt of your further instructions.


