This file reveals that Mrs. HARAFUJI owned no real property in any protected area of B.C. and did not carry any Fire Insurance.

CHATTELS: Mrs. HARAFUJI made her declaration to the Custodian on April 28/42 and was evacuated on Sept. 8/42. She declared chattels as shown on Chattel Schedule consisting of 2 boxes, one trunk, 2 wash tubs, and a tub of shoyu sauce. The contents of these boxes, etc. are given on Chattel Schedule.
