Dear Sir:

Your file has come under review for closing, and we take this opportunity of giving you a brief summary of our administration of your affairs.

When making your declaration to the Custodian on the 27th April, 1942, you stated that a quantity of household furniture had been left with Mr. H. Morgan of Naney. Mr. Morgan has now paid to this office, the sum of \$30.00 representing full purchase price of the chattels left in his care in accordance with your letter to him. A cheque for this amount, which represents your credit balance at this office is being forwarded to you through the Department of Labour.

A number of War Savings Certificates which were declared by you as being in your possession, were not brought under the control of the Custodian.

A refund of your Provincial 15 Income Tax for the year 1941 was paid in to this office to your credit. This sum, however, was remitted to you on the 17th January, 1944.

When registering with the Custodian, you declared no liabilities. The Royal Columbian Hospital, however, filed a claim against you for \$18.19. This account was referred to you for confirmation, and upon your remitting the said amount to this office, the Custodian made settlement in full on your behalf.

It would appear that we have accounted for all the property of every kind left by you in the Protected Area which vested in the Custodian, and in order that you may confirm this and acknowledge the cheque, we are enclosing a stamped addressed envelope for your convenience in replying.

The Custodian representatives J. Moryson and W. E. Anderson perused a letter from SANO offering to sell Mr. Morgan all the chattels left in his care for \$30.00. This sum was paid by Mr. Morgan on October 30, 1945 and credited to SANO's account here.
