Kohel IMAI died at New Denver, B. C. on June 11, 1946. He is survived by his widow, Ura, file No. 15098, and one daughter, Hanas.

Neither the deceased nor his wife declared any assets to the Custodian and none are revealed on the file.

A claim was filed against IMAI by the Vancouver General Hospital in the amount of \$150.00. IMAI, in his letter of March 5, 1945, admitted the claim but stated that he had no way of meeting his obligation. The creditors were advised accordingly. The Department of Labour filed a claim for \$80.00 against the Estate of the deceased to cover the cost of his burial. They were advised that neither Kohel IMAI nor his widow had any funds to their credit from which to pay the claim.
