Ryu KOSAKA died at Kamloops, B. C. on April 22, 1944. She is survived by her husband, Jack Waichiro, file #6939, and three sons, Tamotsu, file #6980, Jiro, file #6981, and Masaru, file #6982.

In her Custodian declaration, signed on April 30, 1942, Ryu KOSAKA stated that she owned a sewing machine and some bedroom furniture. As these chattels were not found by the Custodian, it is assumed that she disposed of them prior to her evacuation on August 31, 1942.


