Our fieldmen inventoried this property on the 17th November, 1942, and they made note at the time that some of this man's chattels had been moved by him prior to evacuation to another man's house so as not to be spoiled. IRIZAWA was asked to give particulars of where they were stored but no reply was received, and no further action taken by this office.

All saleable chattels on the property were sold by public auction on the 16th December, 1943 for the net sum of \$31.18.

ACCOUNTS RECEIVABLE: The sum of \$3.52 was received at this office to IRIZAWA's credit being a refund of his 1941 Provincial Income tax.

BONDS & INVESTMENTS: Yoshizo IRIZAWA declared owning a \$50.00 Victory bond and some War Savings certificates, but these were not brought under controby the Custodian.


