Masakichi Murabayashi died in London, Ontario on September 27, 1943, at the age of thirty years. According to information contained in the file, the deceased was single and both his father and mother were dead.

The only asset declared by Murabayashi was an Industrial Insurance Policy with the Prudential Life Assurance Company. No information regarding this policy appears on the file and the Prudential Insurance Company is unable to supply any information.

The only claim filed against the deceased is for the sum of \$15.00 by T. Maikawa Stores Limited. The Japanese was not advised of this claim and it was, therefore, not acknowledged.
