Dear Sir:

In your registration with the Custodian you declared personal property at 743 Keefe Street.

Our investigators visited the premises and found the doors open and premises condemned by the health authorities, and nothing remaining except junk which had been thrown out into the yard.

We assume that you sold your chattels prior to evacuation, and if this is correct, you have nothing remaining in the restricted area of British Columbia requiring our protection.

Please signify the accuracy of this assumption by signing and returning the attached copy of this letter for our record.
