Dear Sir:

You lodged with this office on the 12th of January, 1943, a claim against S. Yoshihara amounting to \$3.00.

We sent the claim to a Mrs. Iwakichi Yoshihara (Shiyo), whose address before evacuation was Clayoquot, B.C., but who had evidently, at one time, lived at R.R. #1, Whonnock, B.C. This woman is 57 years of age and has a husband and some children, the latter are all over 16 years of age. She replied as follows:

"Your letter of enquiry came to me as more than a surprise. I am not even acquainted with any Dr. L. Broe. Who he is and where he lives is a mystery as far as I'm concerned.

Up till the day of my evacuation I lived up on the west coast of Vancouver Island and was in the best of health. Even there I do not have recollections of consulting a doctor. I believe there must be some mistake and ask for your careful investigation before calling on me again."

Under the circumstances will you please supply us with more information. What was the sex of your patient, age, occupation, and any other information which you think would assist us in locating the correct individual.
