Life Insurance:

In a letter received by this office on September 10, 1943 Mr. Ishii stated he was unable to keep up his premium payments on his life insurance and asked us to inform the life insurance company that he was forced to drop his insurance. Accordingly, we got in touch with the Sun Life Assurance Company who sent to Ishii application forms for the Cash Surrender of his policy, No. 2175798. On November 3, 1943 we sent to ISHII a cheque in the sum of \$84.69, made payable to himself and his mother and representing the cash surrender value of the above policy, which cheque was sent to us by the Sun Life for forwarding to ISHII.

VESSEL SUMMARY

In reference to the information on RCMP Sheet of Information that this man was the owner of vessel "K.I." #5726, the records of the Japanese Fishing Vessels Disposal Committee show that the Committee inspected licence for a vessel, listed as "K.I." P.R.5726, Naval No. PR.099-P. The licence was in the name of B. C. Packers Ltd. The vessel was not impounded.

The vessel records give no indication of what interest, if any, ISHII had in this vessel. He did not declare ownership of the vessel when reporting to the Custodian. It would appear therefore that he had disposed of whatever interest he had in this vessel prior to April 30, 1942.
