Re: Tetsuo KAWAGUCHI - Reg. #09249.

We are in receipt of your letter of the 4th instant on the subject of the above Evacuee's policy, No. 2,291,290.

The evidence on this file and also that of his mother contradict his statement with regard to his Policy. He signed a declaration to the effect that he had no property of any kind in the protected area and his mother had all her personal effects, including a trunk, shipped to her from Courtenay under a Bill of Lading dated 29th June, 1942, the only effects left behind being two old beds and tables of too little value to either ship or place in storage.

Mrs. Kawaguchi (our file 4607) was repatriated to Japan on the 2nd August, 1946.
