Jun KIZAWA, Reg. 10523

Re: Gasboat #4061, Naval # V.61-W, mentioned on Information from R.C.M.P.

The licence number given could only have been issued at Vancouver.

The naval control number is incomplete. It should probably be V.061-W.

Gasboat Licence 4061 was issued at the Port of Vancouver to the Canadian Fishing Co.Ltd. for the vessel "Oceanic 242".

Naval Control No. V.061-W was issued to the Canadian Fishing Company Ltd. for vessel "Oceanic".

There is no record of this vessel having been impounded.

There is no record (other than the Information from R.C.M.P.) that there was any Japanese interest in this vessel.

Jun KIZAWA did not declare ownership of this vessel.

I do not see that any further action can, or need, be taken in connection with this vessel.
