GENERAL SUMMARY

File No. 7169

Re: Shigeichi UCHIBORI, Reg. No. 00216

This man signed a No Property Card on April 30, 1942, and a JP Form on September 16, 1942. He was evacuated on October 27, 1942.

CHATELS

UCHIBORI reported no personal property left in the protected area. The chattels and real property referred to in letters of January 21, March 15, and March 23, 1943, are handled on the file of Teiji MORISHITA, File No. 5078, and Kentaro EBISUZAKI, File No. 12113.

MONIES OWING

UCHIBORI, a merchant, owner of the Alberni Grocery, 740 Denman Street, reported six Accounts Receivable which had been placed in the hands of Woodworth & Woodworth for collection, and three Accounts which had not been put into the hands of any collection agency.

On May 25, 1944, we wrote to UCHIBORI asking if any of the Accounts not put in the hands of a collector had been paid. No reply was received and no further action was taken by this office.

BONDS

UCHIBORI reported one \$5.00 War Savings Certificate. This was not brought under the control of the Custodian.

Dear Sir:-

I am in receipt of your letter at March 15th regarding the registration of the property of Mr. Taiji Morishita at 466 East Cordova Street, a few days before I left Vancouver. I found out that this property was not registered, so I immediately registered it on Mr. Taiji Morishita's behalf.

The furniture and belongings in this house were already registered under the name of Kentaro Ebisuzaki a few days before the house was registered, I was requested by Mr. Kentaro Ebisuzaki the leaving in the Slocan to register the furniture and belongings he had not done so before his departure. Mr Kentaro Ebisuzaki was living in *THIS HOUSE* period to my occupation.

When I went to the custodian office to register this property, I request the person in charge, to come and check up the furniture and belongings as I had responsibility for these things, because I had registered them, He told me that he would come that very day to check-up but he failed to do so I waited everyday for him, period to my departure but he did not come.

There are no furniture or belonging registered under the name of Mr. Taiji Morishita.
