Suekichi TANEMURA died at Tashae, B. C. on December 15, 1943 at the age of 80 years. According to information on file, he was a widower and had no living relatives.

The only claim filed against the deceased is for the sum of \$50.00 to cover funeral expenses paid by the B. C. Security Commission. They were advised by this office on April 15, 1944 that no funds were available from which to pay the claim.
