PERSONAL PROPERTY SUMMARY

This file reveals that Jiuyemon KONDO owned no real property in any protected area of B.C., and did not carry any fire insurance.

CHATELS: KONDO declared chattels as shown on the Chattel Schedule at 206½ Main St. Chattels at this house were inventoried by the Custodian on June 8/43. The following goods were not found by the Custodian:

cook stove & pipe	1 china cabinet
2 small tables	gramophone & records
7 chairs	wool rug and linoleum rug

The following goods were inventoried by the Custodian but are missing:

3 kitchen tables	1 small tank	1 coal pail
2 beds and springs	2 clocks	1 sleigh

The balance of the goods were sold at auction for the net sum of \$18.17 and this sum credited to his account with the Custodian.

Some of the articles which appear missing may have been of no value and so were discarded.

It is difficult to account for goods not found as they were supposed to be securely locked in a room in the rear of 206½ Main St. However it is noted that the goods were not inventoried for a year after the Japanese had been evacuated.
