A call was made and the tenant referred us to the house owner, Mrs. Copp (Suite 17, 589 Burrard St.), who stated that there was nothing in the house when the Japanese left. As we did not move chattels from here, we must assume that Mrs. Ide sold the sewing machine prior to her evacuation (there was a lapse of four months between registration and evacuation). She probably took the trunk and/or sewing machine with her.
