With reference to your claim of \$2.00 against the above named. We wrote to Koto FURUKAWA, whose address prior to evacuation was Port Hammond, and he replied as follows:-

"This is not right either, account of Dr. Takshara's. My own family doctor was our local white doctor. He never attend city doctors before. Absolutely no accounts nowhere."

The above extract refers to your account which showed the attending doctor as Dr. Takshara.
